
ARTICLES OF INCORPORATION

EFFECTIVE DATE

03/07/00

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- Article I: The name of the corporation shall be: Destiny Promised Refuge Center Inc.
- Article II: The mailing address of Destiny Promised Refuge Center Inc. is: P.O. Box 300963 Fern Park, Florida 32730. The principal place of business shall be: 2840 Copper Ridge Court, Lake Mary, FL 32746
- Article III: The effective date of the corporation is to be March 7, 2000
- Article IV: The purpose of the corporation is:
- Purchasing, building, establishing and supporting agricultural, educational and recreational centers for orphans.
  - Establish training centers for local churches in the U.S. and overseas.
  - Shipping containers of food, clothing, agricultural, educational, and medical supplies to orphanages, churches and other established ministries in the U.S. and throughout the world.
  - Creating media promotions for conferences and special meetings, promoting humanitarian aid for hospital, orphanages and church centers.
  - Writing, self-publishing books, articles, curriculum and distributing brochures, and pamphlets for the aid and understanding of the gospel of Jesus Christ throughout the U.S. and the world.
  - Mission trips: Traveling throughout the U.S. and the world determining the needs for orphan homes, recreational, agricultural and educational centers, and to preach the gospel of Jesus Christ.
- Article V The manner in which the directors hold office will be election by majority vote every three years.
- Article VI In the event of dissolution of the corporation, donated assets will be distributed to a similar 501C(3) organization according to Florida statutes.
- Article VI The initial registered agent for Destiny Promised Refuge Center Inc. will be: Richard D. Greenfield, 4160 Gulfstream Rd, Lake Worth, FL. 33461
