# ARTICLES OF INCORPORATION OF SHAMAR HA MIGDALOR, INC.

The undersigned incorporator, for the purpose of forming a corporation not for profit, pursuant of Chapter 617, Florida statutes, adopt the following Articles of Incorporation.

#### ARTICLE I

Name

The name of this corporation is Shamar Ha MigdalOr, Inc.

### ARTICLE II

#### Principal Address

The principal place of business and the mailing address of this corporation shall be:

#### ARTICLE III

#### **Purposes**

(C) to advance work of charitable groups and any other related or corresponding charitable purpose including distribution of its funds for such purposes to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any subsequent United States Revenue Law).

#### ARTICLE IV

#### Directors

The number of voting Directors shall be 3 and they shall govern the affairs and business of the corporation. The initial Directors are listed herewith as follows:
