**ARTICLES OF INCORPORATION  
OF  
SHAMAR HA MIGDALOR, INC.**

The undersigned incorporator, for the purpose of forming a corporation not for profit, pursuant of Chapter 617, Florida statutes, adopt the following Articles of Incorporation.

**ARTICLE I**

**Name**

The name of this corporation is **Shamar Ha MigdalOr, Inc.**

**ARTICLE II**

**Principal Address**

The principal place of business and the mailing address of this corporation shall be:

**ARTICLE III**

**Purposes**

(A) To be involved in ministry and projects, house of hospitality, missionary work in the United States as well as overseas, and otherwise as the Lord directs;

(B) to receive, maintain and accept as assets of the Corporation any property, whether real, personal, or mixed, by way of gift, bequest, devise, or purchase, from any person, firm, trust or corporation, to be held, administered, and disposed of in accordance with and pursuant to the provisions of these Articles of Incorporation, but no gift, bequest, devise or purchase of any such property shall be received or made and accepted, if it is conditioned or limited in such manner as shall require the disposition of income or principal to any organization other than a "charitable organization", or for any purpose other than charitable purposes with the respective meaning of such quoted terms as defined in Articles VIII and IX, or which would jeopardize the Federal Income Tax Exemption of the Corporation pursuant to Section 501(c)(3) of the Internal Revenue Code of 1954, as now in force or acts in amendment thereof or substitution therefor and this shall apply to any affiliate relationship that this corporation shall enter into or come under any group IRS 501(c)(3) organization;
