**NON-PROFIT ARTICLES OF INCORPORATION  
OF  
FLORIDIANS FOR FAIRNESS, INC.**

**ARTICLE I:**

The name of the non-profit incorporation is **Floridians for Fairness, Inc..**

**ARTICLE II:**

The address of the principal office and mailing address of the corporation is 403 East Park Avenue, Tallahassee, Florida 32301.

**ARTICLE III:**

The specific purposes for which this corporation is organized is to:

- A. Promote, develop, establish, and maintain the common business and economic interest of persons and organizations dedicated to meaningful economic competition as the best way for consumers to get lower costs, better service, and higher quality products;
- B. Promote, develop, and maintain an economic climate in Florida that fosters economic competition and allows ideas to flourish, thus creating and improving the quality of life for all Floridians;
- C. Promote government regulations that are designed to be simple, sensible and promote competition rather than to impede it; and

Do all and everything necessary and proper for the accomplishment of the objects herein enumerated or necessary or incidental to the protection and benefit of the corporation and, in general, to carry on any lawful purpose for which non-profit corporations may be incorporated under Chapter 617, Florida Statutes (1999).

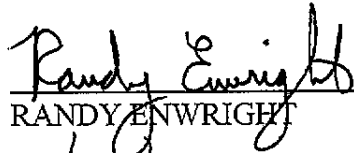
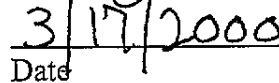
