The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be Cambridge Study Center Foundation Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 1114 Colony Arms Court, Lakeland, Florida 33813

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized is to support secondary and continuing adult education within a religious philosophy through the Cambridge Study Center.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS




