The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation shall be: MAINSTREAM FLORIDA BAPTISTS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is: The advancement of religion, charity, and education by facilitating the cooperation of all Mainstream Baptists throughout Florida and elsewhere, but only and exclusively in such manner as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954, as amended, or under any corresponding provision of any subsequent federal tax laws.

ARTICLE IV - MANNER OF ELECTION OF DIRECTORS
