

ONE: The name and address of this principle corporation is the Pam's Playhouse & Learning Center, Inc., 290 N.W. 11th Ave., South Bay, Florida 33493, in Palm Beach County. This Corporation is organized pursuant to FLORIDA Nonprofit Corporation Code.

TWO: This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. This Corporation is organized under the Nonprofit Public Benefit Corporation Law for Charitable and Educational purposes to aid poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but not limited to: Job Training/Placement, Referrals, Advocacy, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutorial, AIDS Education, Elderly Care and other programs to aid those in need.

THREE: The duration of this Corporation shall be perpetual, no stock and shall have no members.

FOUR: The address of the Registered office is 290 N.W. 11th Ave., South Bay, Florida 33493. The name and address of the registered agent of this Corporation shall be:

FIVE: (a) This Corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.


SIX: The Directors are elected in accordance with the Bylaws. The name and address of the persons appointed to act as the initial Directors of this corporation are:

EIGHT: On the dissolution or winding up of this Corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Educational and Charitable under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the organization is located. Court shall determine which are organized and operated exclusively for such purposes.
