*The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:*

**ARTICLE I - NAME**

The name of the corporation shall be:

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

**ARTICLE III - PURPOSES**

The specific purposes for which the corporation is organized are:

**The Florida Chapter of the American Academy of Medical Acupuncture, Inc. is an organization of physicians practicing Medical Acupuncture. The purpose of the Florida Chapter of the American Academy of Medical Acupuncture is to provide Medical Acupuncture educational opportunities, expand AAMA membership, increase the public and medical community awareness of Medical Acupuncture, and serve as a foundation for liaison communication.**
