ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of

UNITED FUTBOL CLUB, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** Amendment(s) adopted:

ARTICLE III

The general purpose and objects for which this corporation is as follows:

To solicit funds for expenditures of the club for the expenses of the travel program. To organize and run youth soccer programs and to engage in all lawful acts or activities not for the pecuniary profit for which Florida not-for-profit corporations may be organized. The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IX

AMENDMENT TO BY-LAWS AND ARTICLES OF INCORPORATION

The by-laws of the corporation are to be made, altered or rescinded by vote of no less than two-thirds (2/3rds) of the Trustee of the Corporation at any business meeting thereof.

Notwithstanding any other provision of the articles, this organization shall not carry on any activities not permitted to be carried on by any activities not permitted to be carried on by an organization exempt from Federal Income tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.


