ARTICLES OF AMENDMENT

OF

VIETNAMESE COMMUNITY OF PENSACOLA, INC. A NON PROFIT CORPORATION

Article V of the Articles of Incorporation of VIETNAMESE COMMUNITY OF PENSACOLA, INC. A NON PROFIT CORPORATION is hereby amended to read:

ARTICLE V - PURPOSE

The corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

Article VIII of the Articles of Incorporation of VIETNAMESE COMMUNITY OF PENSACOLA, INC. A NON PROFIT CORPORATION is added to read:

ARTICLE VIII - LIMITATION OF ACTIVITIES

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

Article IX of the Articles of Incorporation of VIETNAMESE COMMUNITY OF PENSACOLA, INC. A NON PROFIT CORPORATION is added to read:

ARTICLE IX – DISSOLUTION

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e., charitable, educational, religious or scientific (or corresponding section of any future Federal tax code), or shall be distributed to the Federal government, or to a state or local government for public purpose.

There are no members entitled to vote on these Articles of Amendment.

These Articles of Amendment were unanimously approved by the board of directors of the corporation in its Minutes of Action dated 6/20/2.
