OF
GAINESVILLE HILLEL, INC.**

THE UNDERSIGNED hereby make, subscribe, swear, acknowledge and file these Articles of Incorporation of **GAINESVILLE HILLEL, INC.**

1. NAME

The name of the corporation shall be **GAINESVILLE HILLEL, INC.**, hereinafter referred to as the "Association" or "Corporation".

2. PURPOSE

This Corporation is organized for the purpose of owning property to be used exclusively for purposes set forth in Section 501(c)(3) of the Internal Revenue Code.

3. POWERS

The powers of the Association shall include and be governed by the following provisions:

3.1 The Association shall have all of the common law and statutory powers of a corporation not-for-profit which are not in conflict with the terms of these Articles.

3.2 The Association shall have all of the powers reasonably necessary to implement its purpose.
