(Pursuant to Section 617.1006 of the Florida Not For Profit Corporation Act)

The undersigned does hereby certify, pursuant to Section 617.1002(1) of the Florida Not For Profit Corporation Act (the "Act"), that:

1. Article I is hereby deleted in its entirety and is amended to read as follows: The name of the Corporation shall be GAINESVILLE JEWISH STUDENT FOUNDATION, INC., hereinafter referred to as the "Association" or "Corporation".
2. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain in full force and effect.
3. The Corporation has no members; therefore, these Articles of Amendment were adopted by the Board of Directors of the Corporation as of the 5th day of April, 2018, in accordance with Section 617.1002(1)(b) and 617.1006(4) of the Act.
