**ARTICLES OF INCORPORATION OF
FARO DE LUZ INTERNACIONAL
A MINISTRY OF CENTRO CRISTIANO LATINOAMERICANO GETSEMANI

We the undersigned persons of the State of Florida, each being competent to contract, hereby form ourselves and our successors into a corporation not for profit under Chapter 617, Law of Florida, 1959, and do hereby adopt the following Articles of Incorporation as our Charter:

ARTICLE I - NAME

The name of the corporation shall be FARO DE LUZ INTERNACIONAL A MINISTRY OF CENTRO CRISTIANO LATINOAMERICANO GETSEMANI ASAMBLEAS DE DIOS OF GAINESVILLE, FLORIDA, INC., and its principal place of business shall be 4424 NW 13th St. Suite A-11 Gainesville, Alachua County, Florida 32609. The mailing address of the Corporation shall be PO Box 4116, Gainesville, FL 32613.

ARTICLE II - PURPOSE AND PREROGATIVES

The general nature and object of this corporation is to establish and publish a Christian Spanish newspaper. Providing strength to Christian fellowmen whose faith is precious, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the gospel of Jesus Christ by the printed page, both at home and in foreign lands. Those, whose names appear upon the roster of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios of Gainesville, Florida Inc. as of the date of this signing, do hereby recognize ourselves as a Spanish Christian Newspaper and a ministry of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios of Gainesville, Florida, Inc. We adopt the following principles and submit ourselves to be governed by them.

This Ministry shall have the right to govern itself according to the standards of the New Testament Scriptures, "endeavoring to keep the unity of the faith, and of the knowledge of the Son of God, unto a perfect man, unto the measure of the stature of the fullness of Christ": Ephesians. 4:3,13.

ARTICLE III - AFFILIATION

While maintaining its inherent rights to sovereignty in the conduct of its own affairs, this Ministry shall voluntarily enter into full cooperative fellowship with organizations of like precious faith.

ARTICLE IV - TENETS OF FAITH

This Ministry accepts the Holy Scriptures as the revealed will of God, the all-sufficient rule of faith and practice, and for the purpose of maintaining general unity, adopts the following Truths from the word of God:

1- THE SCRIPTURES INSPIRED

The Scriptures, both the Old and New Testaments, are verbally inspired of God and are the revelation of God to man, the infallible, authoritative rule of faith and conduct (2 Tim. 3:15-17; 1 Thessalonians. 2:13, 2 Peter 1:21).

2- THE ONLY TRUE GOD

The only true God has revealed himself as the veritable being, eternal "I AM", the Creator of heaven and earth and the Redeemer of the human race. He has also revealed himself incorporating the principles of kindred and association as Father, Son, and Holy Spirit (Deuteronomy 6:4, Is. 43:10,11).

3- THE DEITY OF THE LORD JESUS CHRIST

The Lord Jesus Christ is the eternal Son of God. The Scriptures declare:

- a) His virgin birth (Matt. 1:23; Luke 1:31,35)
- b) His sinless life (Hebrews 7:26; 1 Peter 2:22)
- c) His miracles (Acts. 2:22; 10:38)
- d) His substitutionally work on the cross (1 Cor. 15:3; 2 Corinthians 5:21)
- e) His bodily resurrection from the dead (Matt. 28:6; Luke 24:39; 1 Corinthians 15:4)
- f) His exaltation to the right hand of God (Acts 1:9,11; 2:33; Hebrews 1-3)

4. THE HOLY SPIRIT

The Holy Spirit is the third person of the Trinity, he speaks, manifest His will to man and live within the believer. Is the one that inspires all of our writings in this newspaper. (Ephesians 2:8)

ARTICLE V- OFFICERS

The Pastor of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios shall serve as the President of this Corporation. There shall also be a Secretary and a Treasurer. Other officers may be added as needed. Their elections shall be as follows.

Section I - President

The President of the Corporation shall be elected by the general membership of the Centro Cristiano Latinoamericano Getsemani Asambleas de Dios, also members of Faro de Luz Internacional, in accordance with the general bylaws of mentioned corporation.

Section II - Secretary

The Secretary shall be elected by the Official Board of Trustees/Elders of Centro Cristiano Latinoamericano Getsemani Asambleas de Dios, also members of Faro de Luz Internacional, in accordance with the provisions of the corporate bylaws. The secretary shall be responsible for recording the minutes of all meetings of the Official Board of Trustees/Elders and of meetings of the membership of the assembly. He/she shall be at least 21 years of age and shall have been a member of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios for at least one (1) year.

Section III - Treasurer

The Treasurer shall be elected by the Official Board of Trustees/Elders of Centro Cristiano Latinoamericano Getsemani Asambleas de Dios, also members of Faro de Luz Internacional, in accordance with the provisions of the corporate bylaws. The Treasurer shall be entrusted with all finances of the Corporation and shall be responsible for keeping financial records. He/she shall be at least 21 years of age and shall have been a member of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios for at least one (1) year.

ARTICLE VI - FINANCES

All funds for the maintenance of the corporation shall be provided by the voluntary contributions, donations and offerings of the members, friends, churches and business that will like to be recognized on the publication of the newspaper. Offerings shall be accepted by the corporation at such times and in such ways as agreed upon by the Pastor and the Official Board of Trustees/Elders, and shall be administered by the Treasurer under their direction. (Malachi 3:10, Luke 6:38; 1 Corinthians. 16:1; 2 Corinthians. 9:6-8).

ARTICLE VII - DURATION

This corporation shall have perpetual existence.

ARTICLE VIII - AMENDMENTS

Section I

These Articles of Incorporation may be amended at a special meeting of the membership of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios called for that purpose, by a two-thirds (2/3) vote of those present. Bylaws may be made, altered or rescinded in the same manner as provided herein for amending the articles of Incorporation.

Section II

Amendments may also be made at a regular meeting of the membership of Centro Cristiano Latinoamericano Getsemani Asambleas De Dios when notice has been given, as provided by the bylaws of intention to submit such amendments.

Section III

It shall be understood that this article does not apply to the articles of faith, which stand regardless of majority.

ARTICLE IX - INITIAL BOARD OF TRUSTEES/ELDERS

The initial Board of Trustees/Elders shall be as follows after the first Official meeting of the official Board of Trustees/Elders are:

José M. Zamot - Treasurer


