ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming a corporation pursuant to Chapter 617.0202, Florida Statutes, under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I.

The name of the Corporation shall be 4Dreams Ministries, Inc.

ARTICLE II.

The principal place of business and mailing address of this corporation shall be P.O. Box 6783 Jacksonville, Florida 32236-6783

The period during which the Corporation shall continue is perpetual.

ARTICLE III.

The specific purpose(s) for which the corporation is organized are:

- A. To undertake the spreading of the Gospel of Jesus Christ, religious messages and education through publications, personal contacts, or otherwise, to disseminate tape messages, books, and related material to spread the Word of God, in general, to engage in prayer activities and religious ministry to the general public and patrons.
- B. To provide reading and art programs to teach, promote self-esteem and encourage children and adults in geographical areas of the city that are neglected or denied from such resources (i.e. low income, homeless and violence abused).
- C. To provide referrals and resources to families with personal needs (food, clothing, shelter and furniture).
- D. To assist and guide families through counseling, demonstrations, and workshops designed to socialize and familiarize families with what it takes to maintain a stable family life while providing related support services.
- E. In fulfillment and furtherance the educational/religious objective outlined above, and after becoming a nonprofit tax exempt corporation will seek funds through fund-raisers, charitable organizations, donations and contributions from the general public, or from a combination thereof. Such funds are to provide necessary transportation of personnel, resources and facilities to carry out the task of this corporation.
- F. All of the above shall be accomplished without regard to race, creed, gender or sexual orientation.

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and, nothing therein shall be deemed as prohibiting the corporation from extending its activities to any lawful nonprofit purposes or activities which may become necessary or desirable for the furtherance of the corporate objectives heretofore expressed above.

ARTICLE IV:

The number of directors, not less than three, shall be elected as stated in the bylaws.




