ARTICLE I

THE NAME OF THIS CORPORATION IS JUBILEE CHRISTIAN CENTER IN CHRIST, INC.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS IS AT 2800 WOODLAKE DR. NE APT. 103, PALM BAY, FL 32905. THE MAILING ADDRESS OF THIS CORPORATION IS P.O. BOX 120163 WEST MELBOURNE, FLORIDA 32912-0163

ARTICLE III

THE CORPORATION IS A NOT FOR PROFIT CORPORATION. THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED ARE:
TO FURTHER CHRISTIAN EVANGELISM THROUGH THE PROCLAMATION OF THE GOSPEL OF JESUS CHRIST AND THE CHRISTIAN MINISTRY THROUGH WORSHIP, EQUIPPING INDIVIDUALS FOR PERSONAL MINISTRY WITHIN THE COMMUNITY AND FELLOWSHIP, AND ORDAINING OF MINISTERS; TO ENCOURAGE, ASSIST AND ENGAGE PERSONS GATHERED OR DESIRING TO BE GATHERED AS A CONGREGATION.

ARTICLE IV

THE POWERS OF THIS CORPORATION SHALL BE EXERCISED, ITS PROPERTY CONTROLLED, AND ITS AFFAIRS CONDUCTED BY A BOARD OF DIRECTORS. THE NUMBER OF DIRECTORS OF THE CORPORATION SHALL NUMBER NOT LESS THAN 3, NOR MORE THAN 9 MEMBERS. SAID DIRECTORS SHALL HAVE THE AUTHORITY AND POWER TO INCREASE OR DECREASE THE NUMBER OF SERVING DIRECTORS WITHIN THE LIMITS PROVIDED ABOVE. THE BOARD OF DIRECTORS MAY FILL ANY VACANCY WHICH MAY OCCUR ON THE BOARD OF DIRECTORS PENDING THE NEXT ANNUAL MEETING OF EITHER THE MEMBERS OR THE BOARD OF DIRECTORS. THE PERSON APPOINTED TO SERVE ON THE BOARD OF DIRECTORS MAY BE APPOINTED TO SERVE FOR A TERM OF ONE YEAR. THE FIRST BOARD OF DIRECTORS SHALL BE COMPOSED OF THE THREE FOLLOWING PEOPLE: ROY CLEMMONS, BOBBIE CLEMMONS, AND BETTY KARIKER. AND THE AFORESAID BOARD OF DIRECTORS SHALL HOLD OFFICE UNTIL THE FIRST ANNUAL MEETING OF THIS CORPORATION HEREIN PROVIDED FOR AND UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.

ALL PRESENT MEMBERS OF JUBILEE CHRISTIAN CENTER IN CHRIST, INC. SHALL BE MEMBERS OF SAID CORPORATION AND ALL MEMBERS HEREAFTER ADDED IN ANY MANNER TO SAID CHURCH SHALL RECEIVE MEMBERSHIP; HOWEVER NO MEMBER OF THIS CORPORATION SHALL HAVE ANY VESTED RIGHT OF INTEREST WHATSOEVER IN THE PROPERTY OF THIS CORPORATION. THE BUSINESS AFFAIRS OF THE CORPORATION SHALL BE MANAGED BY THE PRESIDENT (WHO SHALL BE THE PASTOR OF THE CHURCH), THE VICE-PRESIDENT, THE SECRETARY, THE TREASURER AND THE BOARD OF DIRECTORS. THE OFFICE OF PRESIDENT SHALL BE FILLED BY THE PASTOR OF JUBILEE CHRISTIAN CENTER IN CHRIST, INC. THE OFFICE OF VICE PRESIDENT, SECRETARY AND TREASURER SHALL BE ELECTED BY THE BOARD OF DIRECTORS AT AN ANNUAL ELECTION AFTER THE FIRST YEAR OF OPERATION. THE MANNER OF ELECTION AND/OR APPOINTMENT OF OFFICERS AND DIRECTORS, IN FILLING VACANCIES OCCURRING BETWEEN THE ANNUAL MEETINGS OF THE CORPORATION, DUE TO RESIGNATION, DEATH OR OTHERWISE SHALL BE PRESCRIBED BY THE BY-LAWS OF THIS CORPORATION AND/OR PRESIDENT'S SUPERVISION.

ARTICLE V

THE STREET ADDRESS OF THE INITIAL REGISTERED OFFICE OF CORPORATION IS 2800 WOODLAKE DR.NE. APT 103 CITY OF PALM BAY, COUNTY OF BREVARD, STATE OF FLORIDA, 32905. THE NAME OF ITS INITIAL REGISTERED AGENT AT SUCH ADDRESS IS PASTOR ROY D. CLEMMONS.

ARTICLE VI

THE BOARD OF DIRECTORS ELECTED THE FOLLOWING OFFICERS: PRESIDENT, VICE-PRESIDENT, SECRETARY AND TREASURER, AND SUCH OTHER OFFICERS AS THE BY-LAWS OF THIS CORPORATION MAY AUTHORIZE THE DIRECTORS TO ELECT FROM TIME TO TIME. INITIALLY, SUCH OFFICERS SHALL BE ELECTED AT THE FIRST ANNUAL MEETING OF THE BOARD OF DIRECTORS. UNTIL SUCH ELECTION IS HELD, THE FOLLOWING PERSONS SHALL SERVE AS CORPORATE OFFICERS:

ARTICLE VII

IN THE EVENT OF DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF 501(c)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE DISPOSED OF BY A COURT OF COMPETENT JURISDICTION OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
