The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be: TRUE BELIEVERS CHURCH INC.

### ARTICLE II PRINCIPAL OFFICE

### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is(are): SEC. 1. The Church shall hold AS ITS IMPERATIVE DUTY TO MAKE KNOWN THE GOSPEL OF JESUS CHRIST OF NAZARETH THROUGHOUT THE ENTIRE WORLD, AND TO TEACH THE WORD OF GOD TO THE END, THAT THOSE WHO BELIEVE MAY BE CONFORMED TO THE IMAGE OF JESUS CHRIST. SEC 2. ### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is: IN Aug. of each year the Church shall ACTIVATE A COMMITTEE TO OBTAIN FROM QUALIFIED MEMBERS, CANDIDATES FOR THE OFFICES OF THE INC. FOR THE COMING YEAR. THE LIST OF QUALIFIED NOMINEES WILL BE PRESENTED AT THE SEPT. MEETING. DIRECTORS WILL BE ELECTED BY A SIMPLE MAJORITY OF THE ELIGIBLE VOTERS PRESENT AT THE OCT. MEETING. A QUALIFIED MEMBER CAN NOMINATE ANY OTHER QUALIFIED MEMBER. PROVIDED THE NOMINEE IS WILLING TO SERVE.
