ARTICLES OF INCORPORATION

We, the undersigned, natural persons of the age of eighteen years or more, acting as incorporators of a Corporation under the laws of the State of Florida, adopt the following articles of incorporation for such Corporation:

First: The name of the Corporation is **PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC.**

(a) The period of its duration is Perpetual.

Second: The principal Place of business is 1805 N. Florida Ave. Tampa P.O. Box 76832 Tampa FL 33675.

Third: The purposes for which **PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC.** is organized are:

1 (a) Helping the Creole and French spoken Communities to integrate themselves in their living area by providing to them the adequate formation and information using all forms of the telecommunication spectrum (radio, television, internet, intranets, newspaper, magazine etc.)

(b) Assisting, the Local, State and Federal Agencies, Private or Public Companies, For profit or Nonprofit Organizations, by helping in the diffusion of their educational and formation programs to the Creole and French spoken Communities.

(c) Providing the technical help to other Nonprofit Organizations, to reach the Creole and French Communities, in their Programs.

(d) Using the Donations, Grants, Gifts and other form of assistance to develop a better formation environment for the Creole and French spoken Communities in their living area.

2. PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC. is a not-for-profit corporation organized under chapter 617, Florida Statutes. It is not organized for the private gain of any person.

3. To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

4. Provided, however, that **PLM INC.** shall not engage in any action which is not permitted to be carried on by nonprofit incorporations under the Internal Revenue Code and no part of the net earnings of **PLM INC.** shall inure to the benefit of or be distributable to its Members, Directors or Officers; But **PLM INC.** shall be authorized and empowered to pay reasonable compensation to these people for services rendered, and make payments and distributions in furtherance of its stated purposes.

5. PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC. shall commence business with the minimum of US\$ 200.00

Fourth **PROJET LA METROPOLE /PROJE LA METROPOL (PLM) INC.** shall have Voting Members, who shall be elected by Voting Members, and who shall have all the rights and privileges of members of the Incorporation. The bylaws may provide for Nonvoting Members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the Bylaws, but who shall not have the right to vote. Fifth: **PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC.**

Provisions descriptive of its Internal Structures shall be in its Bylaws.

Sixth: The official Languages of **PROJET LA METROPOLE / PROJE LA METROPOL (PLM) INC.** are French and Creole.

English shall be use to intercommunicate with government and/or private Entities.

Its motto: **MEN NAN MEN NA RIVE PI DEVAN (hands in hands we will go farther)**

Its emblem: **a Newspaper on the left corner and Audio-Visual materials on the right corner of the Letterhead.**

Seventh: the Officers of **PLM INC.** shall consist a General Secretary, Secretary and Treasurer. Other Officers may be provided for in the Bylaws. Each Officer shall be elected by the Board of Directors at such time and in such manner as may prescribed by the Bylaws. 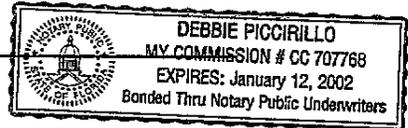
