The enclosed 2009 Not-For-Profit Corporation Annual Report filed by Matthew Belkin and Donald White on March 24, 2009 is intentionally falsified. I have not given my permission for my name or address to be used by Town Square of Delray Association, Inc. nor did I serve on the board at the time of this filing. Nor have I subsequently served on the board.

Matthew Belkin is our past and current HOA president. Donald White works for Haag Management and was and is our current paid, off-site property manager.

I resigned as a board member in August of 2008, 7 months prior to this filing. Please see the enclosed email from Donald White dated 3/12/09 showing that he is not confused about the status of the board membership for our community.

At the time of this filing to the state, only Matthew Belkin and Paul Silver were on the board. (Paul Silver filled a vacant position without election.) Mr. Belkin, Mr. Silver and all residents were made aware the violation would not be tolerated (see enclosed). We were all disappointed when they responded days later by filing a false report, rather than correcting the problem. The position was not filled until May at the delayed annual meeting. Continued illegalities keep them in their positions.
