ARTICLES OF INCORPORATION OF COBRA BAND PARENTS, INC

Articles of Incorporation of Cobra Band Parents, Inc. The undersigned incorporator for the purpose to form a Corporation under the Not for Profit Corporation Act of Florida, hereby adopt(s) the following Articles of Incorporation::

ARTICLE 1 NAME

The name of the Corporation shall be: Cobra Band Parents, Inc.

ARTICLE 11 PRINCIPAL OFFICE

The place in this state where the principal office of the Corporation is to be located is \$\frac{10}{10}\$ Edwards Road, Fort Pierce, Florida 34982

ARTICLE III PURPOSES

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is either by a nominating committee or the membership prior to the close of nominations and shall be qualified for those positions by being a member of the Corporation. Directors shall be elected by majority vote of the membership present during the annual meeting of the Corporation as set from time to time by the membership.

ARTICLE VI LIMITATIONS OF OPERATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and

distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
