

ARTICLES OF INCORPORATION
OF

The undersigned Incorporator to these Articles of Incorporation, a Florida Nonprofit Corporation, Pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is:

MIAMI KILLIAN HIGH SCHOOL CAGETTES, INC. a Florida Nonprofit Corporation

ARTICLE II. PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the corporation shall be:

ARTICLE III. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this not for profit corporation is to engage in the business of a civic and scholastic organization whose primary business purpose is to represent Miami Killian High School through a dance and cheerleader team, comprised of students from that senior high school known as the Miami Killian High School Cagettes. In addition, this organization will transact all business permitted under the laws of the United States and the State of Florida.

ARTICLE IV. MANNER OF ELECTION OF DIRECTORS

The directors of the corporation shall be elected by a majority of the members of the corporation.

ARTICLE V. LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.




