JOSHUA 1:9 OUTREACH MINISTRY, INC. hereby forms a religious corporation not for profit in accordance with the provisions of Chapter 617, Florida statutes, and all amendments relating thereto and hereby adopts the following articles of incorporation:

ARTICLE I

THE NAME AND ADDRESS

The name of the corporation is **JOSHUA 1:9 OUTREACH MINISTRY, INC.** with a physical address at 1324 Hitakee Ave. Sebring, FL 33870.

ARTICLE II

PURPOSE





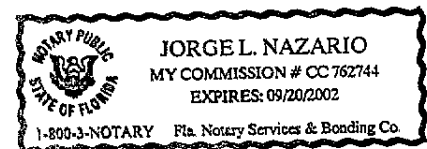

BY WHOM AND MANNER AMENDMENTS TO THE ARTICLES OF INCORPORATION MAY BE PROPOSED AND ADOPTED




ARTICLE IX

DISTRIBUTION OF ASSETS UPON DISSOLUTION


