We, the undersigned, with other persons being desirous of forming a not-for-profit corporation for philanthropic and educational purposes under the provisions of chapter 617 of the Florida Statutes, do agree to the following:

ARTICLE I
(NAME)

The name of the corporation shall be: EMILIO PUJOL CLASSICAL GUITAR FOUNDATION, INC.

ARTICLE II

The principal place of business and mailing address of this corporation shall be:

ARTICLE III
(PURPOSE)

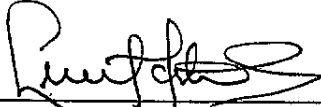
