ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of this organization shall be known as the Moton Elementary School Parent Teacher Organization, Inc.

ARTICLE 2 - PRINCIPAL OFFICE

The principal place of business and mailing address shall be:

7175 Emerson Rd.
Brooksville, FL 34601

ARTICLE 3 - PURPOSES

The purposes of this organization shall be :

- A. To create a closer relationship between home and school in order to enhance cooperation between parents, teachers, staff, and administration in the educational process, and,
- B. To bring about a better understanding of the educational program and school policies.

ARTICLE 4 MANNER OF ELECTION OF DIRECTORS

A. Election

1. Election of officers shall be done at the regular April meeting, and the elected officers shall assume their duties at the end of the May meeting.
2. The nominations for officers shall be made from the nominating committee. Nominations may be made from the floor. All nominees must give consent for their names to be placed in nomination.
3. Officers shall be elected by majority vote of the members present and voting, with the exception of the teachers representative.
4. Officer terms left vacant may be filled at any time by the appointment of the executive board. Ratification of each appointment by the membership is necessary at the next regular meeting.
5. The Teacher Representative shall be elected by nomination and majority vote of the teachers who are members in good standing of the MESPTO.

B. Tenure

1. A person shall not be eligible to serve more than two consecutive terms in the same office.
2. Officers elected to finish an unexpired term may serve two additional consecutive terms in a particular office.
