Of

The undersigned Incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

Article I

The Name of the Corporation shall be Spreading Life Ministries, Inc.

Article II

The period of duration of the corporation shall be perpetual.

Article III

The purpose for which this corporation is organized is to be a Ministry Residential Outreach program for ex-offenders. To do everything necessary, proper, advisable, or convenient for the accomplishment of said purposes, and to do all other things incidental to them; or connected with them that are not forbidden by the Florida Corporation Laws or by other law, or by these Articles of Incorporation, and to carry out the said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the land, the state, territory, district, or possession of the United States or by the foreign country.

Article IV

The Initial street address for the Registered office of the corporation is: 750 South Orange Blossom Trail Suite #102 Orlando, Fl 32805

The Name of the Registered Agent at such address is Norman T. Williams.

Article V

The Initial Board of Directors shall consist of three (3) members, who need not be residents of the State of Florida or Shareholders of the corporation.

The Directors are elected at the annual meeting.

Article VI

And hold office until resignation or termination by the board of directors.
