The Undersigned, acting as incorporator of a corporation not for profit pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such corporation.

ARTICLES

The name of this corporation shall be MOUNT CARMEL MISSIONARY BAPTIST CHURCH OF JUPITER INC. The mailing address of this corporation shall be:

ARTICLE II

The existence of this corporation shall be perpetual.

ARTICLE III

The purposes of the MOUNT CARMEL MISSIONARY BAPTIST CHURCH OF JUPITER INC. are:

- 1) To provide a place for christian worship and fellowship for all its members.
- 2) To give primacy to the spiritual rather than to the material values of life.
- 3) To encourage christian daily living of all members and their families.
- 4) To develop, by precept and example, a more intelligent, aggressive, and serviceable christian citizenship.
- 5) To provide through this Church, a practical means to form enduring friendships, to render altruistic service, and to build better christian communities.
- 6) To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, and christian ministry.
- 7) To do all such things as are incidental or conducive to the attainment of the above objectives.

ARTICLE IV

The qualifications of members and the manner of their admission shall be in accordance with the provisions set forth in the By-Laws.

ARTICLE V

The Board of Directors shall consist of all elected officers and seven additional elected directors. Election of officers and directors shall be in accordance with the By-Laws. The names and addresses of the initial Board of Directors are:

This corporation is organized under a non-stock basis.

ARTICLE VII

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) of the Internal Revenue Code or any corresponding sections of any prior or future law, or to the federal, state or local government for exclusive public purpose.

ARTICLE VIII

These Articles may be amended by a two-thirds vote of the membership of the corporation at a duly noticed meeting.

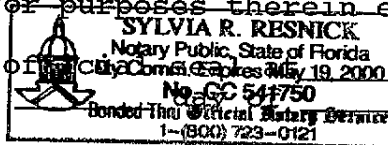
