ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of  
Hardee Volunteer Firefighters Association, Inc.

*Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to it's articles of incorporation.*

**FIRST: Amendments adopted:**

**ARTICLE III PURPOSES is amended to read:**

- (a) To promote the understanding, appreciation, and awareness of volunteer firefighting, and volunteer emergency medical services among the public and to assist in the equipping, education and safety of volunteer firefighters and volunteer emergency medical providers serving the Hardee County area;
- (b) To acquire and/or maintain equipment and property to be used in fire prevention, fire suppression, and emergency medical services in the Hardee County area;
- (c) To pay the expenses of carrying out the purposes of the Corporation;
- (d) To receive, maintain, and dispense funds and other property for the advancement of the corporation.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS is amended to read:**

- (a) The president, secretary, and treasurer serve as three of the nine directors, the remaining six directors will be elected by the Executive Committee of the Corporation. One director will be chosen from each volunteer fire or EMS department that serves Hardee County, and the remainder from the Hardee County Fire Rescue Volunteers;
- (b) The officers of the Corporation shall be elected annually by the Board of Directors of the Corporation.

**ARTICLE V REGISTERED AGENT is amended to read:**

**SECOND:** The date of adoption of the amendments was September 18<sup>th</sup> 2000


**THIRD: Adoption of Amendment:**
