**ARTICLES OF INCORPORATION
OF
FLORIDA INFORMATION TECHNOLOGY CORPORATION
(A Florida Not For Profit Corporation)**

The undersigned, acting as incorporator of a corporation, pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the Corporation shall be Florida Information Technology Corporation.

ARTICLE II

Principal Place of Business and Mailing Address

The principal place of business and the mailing address of this Corporation shall be 3411 Capital Medical Boulevard, Tallahassee, Florida 32308.

ARTICLE III

Nonprofit Purpose

The Corporation is formed exclusively for purposes for which a corporation may be formed under the Florida Not For Profit Corporation Act and not for pecuniary profit or financial gain. No part of the assets, income, or profit of the Corporation shall be distributable to, or inure to the benefit of, its directors, or officers except to the extent permitted under the Florida Not For Profit Corporation Act. The Corporation shall not engage in any activities, other than insubstantial, which would constitute a regular business of a kind ordinarily carried on for profit.

ARTICLE IV

Purposes

The purposes for which the Corporation is formed are:

- A. To associate parties interested in issues impacting the information technology industry in the State of Florida.
- B. To further the interests of the members of the Corporation with regard to information technology issues.

- C. In furtherance to its corporate purposes, the Corporation shall have all general powers enumerated in the Florida Not For Profit Corporation Act.

ARTICLE V

Incorporator

The name and address of the incorporator is : James M. Hunt, 3166 Shamrock Street East, Tallahassee, Florida 32308.

ARTICLE VI

Directors

The Board of Directors of the Corporation shall conduct the affairs of the Corporation and shall consist of three or more directors, the exact number of which shall be from time to time fixed in accordance with the Bylaws. The Directors shall be elected as provided in the Bylaws.

Distributions Upon Partial Liquidation

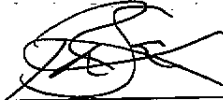
The Corporation may make distributions upon partial liquidation to its members as permitted by applicable Florida law.

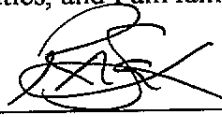

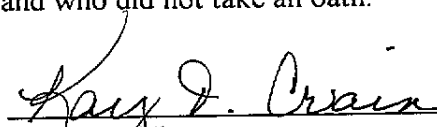
