

ARTICLES OF INCORPORATION OF SOUTH SHORES NEIGHBORHOOD WATCH ASSOCIATION, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I Name

The name of this corporation is South Shores Neighborhood Watch Association, Inc.

ARTICLE II Principal Office

The principal place of business and mailing address of the corporation is 2116 Huntsford Road, Jacksonville, Florida 32207.

ARTICLE III Purpose

The purpose for which this corporation is organized is to enhance and preserve the neighborhood quality of life and conduct all other business allowed by law.

ARTICLE IV Manner of Election of Directors

The directors shall be nominated by the membership of the association at an annual meeting and elected by a majority vote at the next meeting. There shall not be more than five (5), nor less than three (3) directors.

The officers of this corporation shall be nominated by the directors at an annual meeting and elected by a majority vote at the next meeting. Officers shall serve for a term of one year.
