The **FL** is a grass-roots basketball league providing entertainment and enjoyment to 16+ communities throughout the State of Florida and allow athletes to be seen by licensed sport agents for professional basketball contracts to play basketball in the North and South America and European counties.

ARTICLES IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

The directors and executive board will be elected at the first board meeting by ballot through the democratic process with each manager/coach casting one vote for the six seats on this board which would consist of League President, Vice President of Player Operations, Vice President of Media Coverage, Vice President of League Sponsorship, Secretary and Treasurer. Though election process with three year limit on Executive Officers. The board of directors retain the board of director status as long as they are affiliated with the league in a managerial form as owner of their respective teams. When a team ownership is replace due improper conduct, that member is eliminated and the new manager/coach is installed through democratic vote.

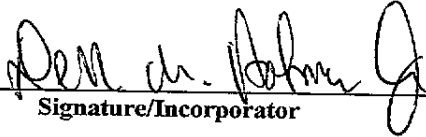

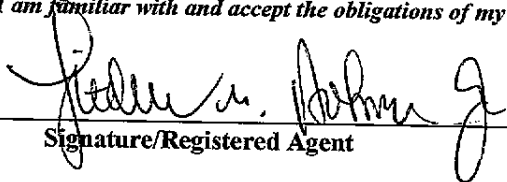
