**ARTICLES OF INCORPORATION
OF

In compliance with the requirements of Florida Statutes, Chapter 617, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a not for profit corporation.

ARTICLE I - NAME

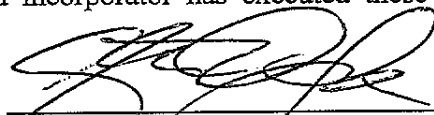

ARTICLE VIII - INDEMNIFICATION

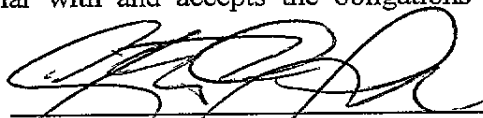
The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
