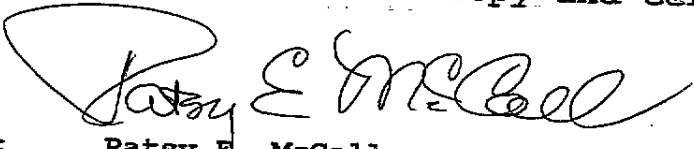

# **GREEN CROSS PROJECTS INCORPORATED**

## **ARTICLES OF INCORPORATION**

### **Article I**

#### **Name of the Corporation**

The name of the corporation is Green Cross Projects, Incorporated, a non-profit corporation.

### **Article II**

#### **Principal Office**

The principal place of business of the Corporation is 1403-C University Center, Florida State University, Tallahassee, FL., 32303.

### **Article III**

#### **Purposes of the Corporation**

The purposes of this non-profit Corporation are to develop a global membership of traumatology professionals, establish standards of practice for trauma intervention, and provide traumatology specialists to communities, which have been affected by disaster. In the event of a disaster or other emergency need, the Corporation will be able to provide trained traumatology specialists from its worldwide membership to the needed location(s). The specialists will be made available to provide information, education, consultation and treatment for traumatized individuals or communities that have been affected by natural or man-made disaster.

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Service Code of 1954 (or the corresponding provision of any future United States Internal Revenue law).

**Article IV**  
**Manner of Election of Directors**

The corporation shall be governed by a Board of Directors, comprised of at least seven members and elected by the membership in keeping with the established by-laws. An organizing committee was established on May 31, 1998, which members agreed to comprise a temporary Board of Directors. Vacancies in the Board of Directors are filled in accordance with the Bylaws of the corporation. A Director is elected for a two-year term or as provided within the by-laws.

The duration of the Corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of these articles of incorporation with the Department of State of the State of Florida.

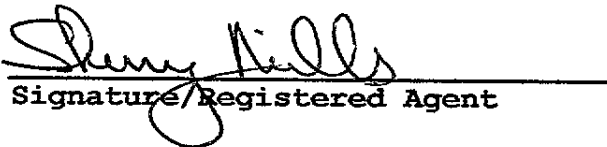
