OF
BISHOP NAMON WILSON JR. MINISTRIES, INC.**



ONE: The name of this principle corporation is ^{Bishop} Namon Wilson Jr., Ministries, Inc. The address for the initial registered office is 3205 Dodge St., Tampa, Florida 33605. The Corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This Corporation is a religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Religious Benefit Corporation Law, to establish structured support service for Evangelistic, Economic Development and to support the outreach ministries for the body of Jesus Christ (The Church). The religious program will consist of Economic Development Programs, but not limited to: Homelessness, Healthcare, Childcare, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

THREE: The duration of this Corporation shall be perpetual, no stock and no members.

FOUR: The name and address of the registered agent of this Corporation shall be:

FIVE: (a) This Corporation is organized and operated exclusively for Religious, Educational and Charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.


SIX: The Directors are elected in accordance with the Bylaws. A director must be at least 18 years of age. The number of Directors shall be three (3). The name and address of the persons appointed to act as the initial Directors of this corporation are:

SEVEN: The property of this Corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefits of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts, and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for, Religious, Educational and Charitable under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose. Any such asset not disposed of shall be disposed by the Court of Common Pleas of the county in which the principal office of the organization is located. Court shall determine which are organized and operated exclusively for such purposes.
