#### ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

### PALM HARBOR UNIVERSITY HIGH SCHOOL CENTER FOR WELLNESS AND MEDICAL PROFESSIONS BOOSTER CLUB, INC.

Pursuant to Florida Statute 617.1002 the Articles of Incorporation of Palm Harbor University High School Center for Wellness and Medical Professions Booster Club, Inc., a not-for-profit corporation, are hereby amended as set forth below:

Article III is hereby amended as follows:

#### ARTICLE III: PURPOSE
