ARTICLES OF INCORPORATION

SECRETARY OF STATE TALLAHASSEE, FLORIDA

Pursuant to the provision of the Non-Profit Corporation Act, Section 617.0202, Florida Statutes, the undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE I Name
