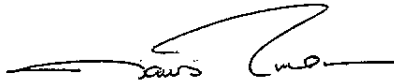
ARTICLE VIII. INDEMNIFICATION

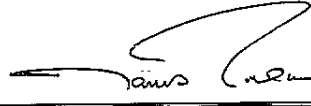
