# AMENDED ARTICLES OF INCORPORATION FOR THE BEACON FOUNDATION, INC.

The undersigned, for the purpose of forming a nonprofit corporation under Chapter 617 of the Florida Statutes hereby forms a corporation not formed for pecuniary profit and adopts the following Articles of Incorporation:

### ARTICLE I. NAME

The name of the Corporation is: THE BEACON FOUNDATION, INC. ("Foundation"). The initial principal office location of the foundation is 731 East Fairlane Avenue, Orlando, Florida 32809. The mailing address is the same.

### ARTICLE II. TERM OF EXISTENCE

This Foundation shall have perpetual existence.

#### ARTICLE III.

#### POWERS, OBJECTIVES AND PURPOSES OF THE FOUNDATION

This Foundation is organized exclusively for charitable, religious, educational, literary and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)3 of the Internal Revenue Code of 1986 (as such Section or corresponding Section of any future federal tax law, may be amended from time to time). The specific purposes for which this foundation is organized are:

- (A). To assist in and contribute to the academic and physical growth and development of the ministries and activities of Pine Castle Methodist Church, Inc. including Pine Castle Christian Academy, an activity of Pine Castle Methodist Church, Inc.;
- **(B).** To provide financial assistance with tuition and other fees to those students of Pine Castle Christian Academy who through merit or need are worthy of assistance.
- (C). To solicit gifts and bequests and to administer funds received in connection with the purposes of the Foundation.

This Foundation shall be authorized to exercise the powers permitted non-profit corporations under Chapter 617 of the Florida Statutes; provided, however, that this foundation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, and provided that this Foundation shall not carry on any activities not permitted to be carried on by (a) a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, or (b) a corporation to which contributions are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments an distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or the distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

### MEMBERSHIP ARTICLE IV.

The sole voting member of the Foundation shall be the Pine Castle Methodist Church, Inc.

# ARTICLE V. NAME AND ADDRESS OF INCORPORATOR

#### ARTICLE VI.

### ARTICLE VII. DIRECTORS

- (A). The number of directors constituting the Board of Directors shall be set by the bylaws; provided however, that there shall never be less than three (3) directors.
- (B). Directors shall have such qualifications as are required by the Bylaws of the Foundation.

  The manner of election and discharge of the directors of the Foundation shall be provided in the Bylaws of the Foundation.
