We, the undersigned incorporators, hereby associate ourselves and make, subscribe, acknowledge and file with the Secretary of State of Florida these Articles of Incorporation for forming a Corporation Not- For- Profit, pursuant to Chapter 617 of the Florida States Statutes.

ARTICLE I - NAME AND GEOGRAPHIC AREA

The name of this Corporation is: **DORCAS' COMPASSION HOUSE, INC.**

The headquarters of this organization will be in the State of Florida.

ARTICLE II - PURPOSES AND OBJECTIVES

This entity is organized and will be operated exclusively as a not- for- profit Corporation under Chapter 617 of the State of Florida Statutes to secure the advancement of the Latin - American citizens in the United States and particularly in the center of the State of Florida.

The purposes for which the corporation is organized are religious and charitable. To provide necessities to widows, orphans, and elderly people. To provide food, clothes, medicines, house furniture, counseling, transportation and other needs through our offices to hospitals and government offices.

ARTICLE III - POWERS

1. To exercise the powers permitted to nonprofit corporations under Chapter 617 of the Florida Statutes.

ARTICLE IV - MEMBERSHIP

The membership of this corporation will constitute the person hereinafter named as officer and director and other persons of good moral character from time to time may become a member by a majority vote of the Board of Directors.

ARTICLE V - TERM OF EXISTENCE

This corporation will have perpetual existence.

The number of Directors will initially be eleven (11), and the number of Directors may be increased from time to time as provided by the Bylaws, but, will never be less than three (3). The names and addresses of the persons who are to serve as Directors for the ensuing year, or until the first annual meeting of the corporation are stated in ARTICLE XI. (Please see Article XI).

Corporation Officers - The officers of the Corporation will be a President, Vice-President, Secretary and other officers, as provided by the Bylaws of this Corporation, that may be authorized by the Board of Directors to be elected from time to time.

This Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment hereto by a majority vote of the Board of Directors. Amendments to these Articles of Incorporation may be adopted by the Directors at any regular meeting or any special meeting called for that purpose.

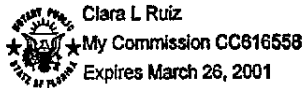
