#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a not-for-profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such notice for-profit corporation:

## ARTICLE I

The name of the not-for-profit shall be the Pilgrim Progress Community Church, Inc.
