ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a not-for-profit corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation of such not-for-profit corporation:

ARTICLE I

The name of the not-for-profit shall be the Pilgrim Progress Community Church, Inc.

The principal place of business of this Church shall be at 5603 Avenue B, Jacksonville, Florida 32209

ARTICLE II

The period of the duration of this Church is perpetual unless dissolved according to law.

ARTICLE III

The purpose of the Church is to provide a place of worship for people in the geographic area in particular, and the City of Jacksonville in general.

ARTICLE IV

The qualifications for members of the board and the manner of their admission or appointment is to be provided for in the Church bylaws, as is the manner in which the directors are elected or appointed.
