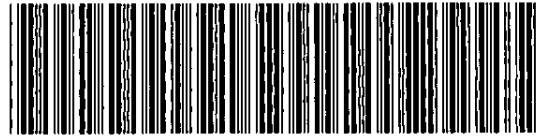



**ARTICLES OF DISSOLUTION
OF
STOP-IT, INC., a Florida not-for-profit corporation**

Pursuant to Section 617.1401, Florida Statutes, Stop-It, Inc., a Florida not-for-profit corporation (the "Corporation") submits the following Articles of Dissolution:

ARTICLE I

The name of the Corporation, as currently filed with the Florida Department of State, is Stop-It, Inc.

ARTICLE II

The document number of the Corporation is N00000002246.

ARTICLE III

The Articles of Incorporation of the Corporation were filed on April 5, 2000.

ARTICLE IV

The Corporation has ceased conducting its affairs.

ARTICLE V

No debts of the Corporation remain unpaid.

ARTICLE VI

All remaining funds in the Corporation's bank account shall be distributed to Sanibel Island-based not-for-profit 501(3)(c) tax exempt organizations, F.I.S.H. of Sanibel-Captiva, Inc. and Community Housing and Resources, Inc., in equal shares, and the bank account shall be closed.


ARTICLE VII
