AMENDMENTS TO ARTICLES OF INCORPORATION FOR

TURTLE BAY III AT BRIDGEWATER BAY CONDOMINIUM CARRIAGE HOMES ASSOCIATION, INC.

Amendment to Article I.

NAME AND ADDRESS: The name of the corporation, herein called the "Association", is Turtle Bay III at Bridgewater Bay Carriage Homes Condominium—Association, Inc. The address of the Association is 2055 Trade Center Way, Naples, Florida 34109.

Amendment to Article II.

PURPOSE AND POWERS: The purpose for which the Association is organized ais to provide an entity pursuant to the Florida Condominium Act for the operation of Turtle Bay III at Bridgewater Bay, a Condominium and any other condominium which is operated by the Association as a result of a corporate merger, located in Collier County, Florida. Except where a contrary meaning is stated, the term "Condominium" shall be deemed to include all condominiums operated by the Association and the term "Declaration" shall be deemed to read "Declarations". The Association is organized and shall exist upon a non-stock basis as a corporation not for profit under the laws of the State of Florida, and no portion of any earnings of the Association shall be distributed or inure to the private benefit of any member, Director or officer of the Association. For the accomplishment of its purposes, the Association shall have all of the common law and statutory powers and duties of a corporation not for profit except as limited or modified by these Articles, the Declaration of Condominium or Chapter 718 Florida Statutes, as it may hereafter be amended, including but not limited to the following:

MEMBERSHIP:

(A) The members of the Association shall consist of all record owners of legal title to one or more units in the Condominium or other condominium operated by this Association, as further provided in the Bylaws.

Amendment to Article VII.

AMENDMENTS: Amendments to these Articles shall be proposed and adopted in the following manner:

- (A) Prior to the recording of the Declaration of Turtle Bay III at Bridgewater Bay, a Condominium amongst the Public Records, these Articles may be amonded by an instrument in writing signed by the President (or Vice President) and the Secretary (or an Assistant Secretary) and filed with the Secretary of State of the State of Florida. The instrument amonding these Articles shall identify the particular Article or Articles being amonded, give the exact language of such amondment and give the date of adoption of the amondment by the Board of Directors. A certified copy of each such amondment shall always be attached to any certified copy of these Articles or a certified copy of the Articles as restated to include such amondments and shall be an exhibit to the Declaration of Condominium upon the recording of such Declaration. This Article VII is intended to comply with Chapter 617, Florida Statutes.
- (BA) After the recording of the Declaration of Condominium of Turtle Bay III at Bridgewater Bay, A Condominium amongst the Public Records, these Articles may be amended in the following manner:
- (1) <u>Proposal</u>. Amendments to these Articles may be proposed by a majority of the Board or by petition of the owners of one-forth (1/4th) of the units in condominiums operated by the Association by instrument, in writing, signed by them.
