The undersigned incorporator hereby files the following Articles of Correction to Articles of Incorporation of The Financial Planning Association of Tampa Bay, Inc., pursuant to Florida Statute 617.0124(1) within ten (10) days of original filing as follows:

**ARTICLE I**

Document to be corrected are the Articles of Incorporation of The Financial Planning Association of Tampa Bay, Inc. a Florida Non-profit corporation filed April 5, 2000.

**ARTICLE II**

Article VI of the Articles of Incorporation of The Financial Planning Association of Tampa Bay, Inc. is incorrect because six directors and their names and addresses were inadvertently omitted. Article VI of the Articles of Incorporation of The Financial Planning Association of Tampa Bay, Inc. shall be amended and corrected in its entirety as follows:

**ARTICLE VI**

**Directors**

The corporate powers and management of the Corporation shall be vested in and exercised by a Board of Directors. The Board of Directors shall be composed of such numbers of members as the Board of Directors shall, from time to time, determine but, at no time shall the Corporation have fewer than (3) three directors. Directors shall be elected or appointed in the manner and for the term prescribed in the bylaws. The Board of Directors may make, alter and amend the bylaws.
