Articles:

I

#### IV

This corporation is a non profit, organization. Anointed and powerful Ministry that God has chosen, called and ordained to preach the Gospel to every living creature. Man, woman, boy and girl. "For God so loved the world, He gave His only begotten Son, that whosoever believeth in Him shall not perish, but have everlasting life".

This organization's object is that,

- A) We shall teach and preach;
- B) We shall teach love and compassion toward one another, mainly with respect for the Constitution of the United States of America and all subdivisions thereunder;
- C) We do safeguard and transmit to posterity the purity and and righteousness and freedom of each individual and teaching of the Lord;
- D) We shall reach out to help the community to assist in charitable works of any nature deemed beneficial to the best interest of the order and to the society as a whole.
- E) We shall cloth the necked;
- F) We shall feed the hungry;
- G) We shall raise funds for caring the same into effect in any manner allowed by the State and permitted under the Constitution of the United States of America;
- H) Members will support the Church and Pastor by the paying of Tithes and Offerings, according to St. Luke 6:38 and Malichi 3:8.

#### V

Membership is open to the public. To all who shall come and partake to the word of God and to take Jesus as his personal Savior

## VI

The duration of this Organization is forever.

## VII

The general officers of this organization shall be the Pastor, Assistant Pastor, Trustees, Deacons, Ministers, and Board Brothers.

A) Pastor is the spiritual leader of the flock, whose job is to be a good, strong, faithful leader, to lead and guide the flock in the ways of the Lord, with oversight and insight in spirit and in truth, The Pastor shall be selected by the Church and remain Pastor until his resignation or death.

B) Assistant Pastor shall carry out the duties of the pastor in his stead, when the Pastor is unable to serve. The assistant Pastor is elected through nomination of the Pastor and selected by the Church, and likewise removed.

C) Trustees shall be responsible for the upkeep of the Church, its financial needs i.e. the purchase and maintenance of such items as musical instruments, chairs, air conditioner, and a place of worship). Trustees are nominated by the Pastor, approved by membership to serve until they resign, or for good cause removed by the board to serve in the same capacity as Directors of the Corporation. They shall meet with the Pastor twice a month, in a place designated by the by-laws of the Church. If someone is removed, the Trustee board has the authority to fill that vacancy. This board also has the authority over all financial dealings (including salaries of all employees of the Church).

D) Deacons shall assist the Pastor in administering to the members of the church. They shall be trustworthy and loyal, exemplifying one who is full of the Holy Ghost. They can be removed by the board in the same manner as the Trustees.

E) Ministers shall assist the Pastor in witnessing for the Lord, spreading the word, praying for the sick. Ministers are called by God, but can be removed for unbecoming behavior by the board upon nomination of the Pastor.

F) Other Officers shall be elected and their duties shall be determined according to the by-laws of this Organization.

#### VIII

The number of initial directors of this Organization, who shall also be on the Board of Trustees and designated Officers of the Church shall be three. The affairs of this Organization shall be conducted by the Directors, whose names and addresses are as follows:
