**Articles of Incorporation
of
PRINCETON RED-NARANJA OPTIMIST
CLUB, INC**

The undersigned subscriber to these articles of incorporation is a natural person competent to contract and hereby form a corporation for not for profit under chapter 617 of Florida Statutes.

**ARTICLE 1
Name**

The name of the corporation shall be The Princeton, Red-Naranja Optimist Club, Inc., hereinafter referred to as the "Corporation."

**ARTICLE 2
Principal Office**

The principal office of the corporation is 26421 SW 134th Place, Naranja, Florida 33032. The corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida.

**ARTICLE 3
Purposes**

The purpose of the corporation is to further certain charitable and educational purposes of the Princeton, Redland, Naranja, Florida, and neiboring communities. Princeton Red- Naranja Optimist Club is a not for profit club which is exempt from tax pursuant to Section 501(c) (4) of the Internal revenue Code, as amended and which meet the requirements described in section 509(a) (2) of the internal revenue code of 1954 as amended if it was an organization described in section 501(c)(3) of the internal revenue code 1954, as amended,transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

ARTICLE 4
Manner of Election

The Board of Directors are nominated by the members of the club, and each nominee is then voted for. The nominee with the most votes becomes the Director. (3) Directors are elected for a two year period and (3) are elected for a one year period. Elections will be held annually. The election process will be amended by the by-laws from time to time.
