**ARTICLES OF INCORPORATION
OF

The Name and address of this principal corporation is The Miracle Ministry of Flaming Fire, Inc., The corporation is organized pursuant to Florida Nonprofit Corporation Code.

Article II

Article III

This corporation is a nonprofit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Nonprofit Public Benefit Corporation Law for Religious purposes to establish structured support services for Evangelistic, Economic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the Corporation creed/bylaws as a pastor to spread the gospel of Jesus Christ. The religious program will consist of Economic and social Development Programs, but shall not be limited to: Homeless, Health Care, Child Care, Youth at High Risk, Tutorial, Housing, Job Training, Job Placement, Counseling, Employment, Marriage Ceremonies, Burial Services, Youth and Singles Activities Center, Bookstore, Conferences, Crusades, Revivals, Seminars, Drama (The Arts), Radio, Television, Tape, Video and Book Distribution, other programs to aid those in need and activities to uplift and build the body of Christ.


