ARTICLES OF INCORPORATION  
MVSKOKE HOPUETAKE, INC.

The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, FLORIDA Statutes, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit, adopts the following Articles of Incorporation of such corporation.

ARTICLE I NAME

The name of this corporation shall be Mvskoke Hopuetake, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and the mailing address of this corporation shall be: 7041 Chantel Drive, Zephyrhills, Florida 33540.

ARTICLE III PURPOSE

The purpose for which this corporation is organized is as follows:

- (a) To provide for the welfare, interest, heritage, tradition and culture of the Creek Indian Tribe.
- (b) To do such things and undertake such projects as may be deemed necessary and desirable by the members of the corporation in the pursuit of the purposes of this corporation.
- (c) To exercise all corporate powers enumerated by the provisions of Chapter 617, Florida Statutes, 1989, and other such corporate powers as may be permitted corporations not for profit by future statutes.
- (d) The corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV MANNER OF ELECTION

The members of this corporation shall be elected by the Tribal Members as provided in the Bylaws and shall have such qualifications as may be prescribed by the Bylaws.

#### ARTICLE V INITIAL DIRECTORS/OFFICERS

The business of the corporation shall be conducted by the Board of Directors (Council Members) which shall consist of not less than three (3) members as shall be designated by the Bylaws. The corporation shall have initially seven (7) directors (council members) and shall be appointed by the members of the corporation annually. The number of directors (council members) may be increased or decreased from time to time by amendment of the Bylaws but there shall never be less than three (3).

All officers and directors shall be indemnified by the corporation against all expenses and liabilities including attorney's fees (including appellate proceedings) reasonable incurred in connection with the proceeding or settlement thereof in which they may become involved by reason of holding such office. The corporation may purchase and maintain insurance on behalf of all officers and directors against any liability asserted against them in their capacity as officers and directors or arising out of their status as such.

#### ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS

The registered office of the corporation shall be at 7041 Chantel Drive, Zephyrhills, Florida 33540 and the registered agent shall be Elizabeth Reichow.


#### ARTICLE VII INCORPORATOR

The name and address of the Incorporator is Jeffrey H. Williams, 7041 Chantel Drive, Zephyrhills, Florida 33540.


ARTICLE VIII RIGHT TO AMEND
