## ARTICLES OF INCORPORATION

Notice is hereby given that the undersigned incorporators have voluntarily associated themselves together for the purpose of forming an agricultural marketing association under the provisions of the Florida Not For Profit Corporation Act and we do hereby accept all of the rights, privileges, benefits and obligations conferred and imposed by such law, and we do hereby make, subscribe, acknowledge and file these Articles of Incorporation:

### ARTICLE I NAME

The name of the corporation shall be the CRAWFORDVILLE RETAIL GREEN MARKET AGRICULTURAL ASSOCIATION, INCORPORATED herein after called the "Association."

### ARTICLE II PRINCIPAL OFFICE

The principal place of business will be Town of Crawfordville, County of Wakulla, State of Florida. The mailing address of this corporation will be 147 Oakland Drive, Crawfordville, FL 32327.

### ARTICLE III PURPOSE(S)

The specific purposes for which the corporation is organized is to engage in any activity for the mutual benefit of its members as producers of agricultural products; to promote the production and marketing of farm and garden products in the area; to stimulate public interest in the consumption of farm and garden products; and to provide an outlet for the sale of farm and garden products to the general public.

### ARTICLE IV MANNER OF ELECTION OF DIRECTORS

SECTION 1. The affairs of the Association shall be managed by a Board of Directors. The Board of Directors shall consist of five (5) persons. Directors shall be elected or removed in accordance with the procedures established in the Bylaws of the Association.

SECTION 2. The officers of the Association shall be President, Vice-President, and Secretary/Treasurer. These officers shall be elected and shall hold office in the manner provided by the Bylaws of the Association.

### ARTICLE V INITIAL REGISTERED AGENT AND STREET ADDRESS
