Articles of Incorporation for Sonrise Community Church of Northeast Florida Inc.

[In Compliance with Chapter 617, F.S., (Not for profit)]

Article I - Name

The name of the non-profit corporation shall be SONRISE COMMUNITY CHURCH OF NORTHEAST FLORIDA INC. This corporation shall be referred to in these Articles as the "Church."

Article II - Principle Office
