We, the undersigned, being desirous of forming a corporation for religious and educational purposes, and under the provisions of Chapter 617, of the Florida Statutes, do agree to the following:

ARTICLE I - Name

The name of this corporation is _____, and the principal office shall be at

ARTICLE II - Purposes

The purposes for which the Corporation is formed are to train and equip indigenous Christians from around the world in order to enable them to meet the physical and spiritual needs of their own people in fulfillment of Christ's Great Commission. This will involve, among other activities, the development of appropriate technologies and specialized training methods to make this equipping and training possible.

ARTICLE III - Membership

The corporation will not have members.

ARTICLE IV - Term of Existence

This corporation is to exist perpetually.

ARTICLE VI - Officers

Section 1. The officers of the corporation shall be president, secretary and treasurer and such other officers as may be provided in the By-Laws.

Section 3. The officers shall be elected by a majority vote of the directors of the corporation present at the annual business meeting of the corporation.

ARTICLE VIII - By-Laws


The directors shall have the right to make and adopt such By-Laws as they shall deem proper and advisable and such By-Laws shall be made, altered, or rescinded upon a majority vote of the directors.

ARTICLE IX - Resident Agent

The name of the initial registered agent of this corporation is Tim Paulson whose address is 10600 SW 110th Street, Dunnellon, Florida 34432, who signed these Articles of Incorporation to indicate his acceptance and agreement to act in this capacity as contemplated by Section 617.0503, Florida Statutes.

ARTICLE X

1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof.

2. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).


3. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

4. Upon the dissolution of the corporation, the Board of Trustees shall, after paying or making provisions for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, religious, educational or scientific purposes as shall at

the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 (or of the corresponding provision of any future United States Internal Revenue Law), as the Board of Trustees shall determine. Any asset not so disposed of shall be disposed of in such manner as approved by order of the Circuit Court of the county in which the principal office is located, upon petition therefor by the Board of Trustees, and after the publication of such notice as the Court may direct.


