THIRD ARTICLES OF AMENDMENT

TO

ARTICLES OF INCORPORATION

A SAME OF SAME

OF

GIVEWELL COMMUNITY FOUNDATION, INC.

The Articles of Incorporation of GiveWell Community Foundation, Inc. (Document number N00000002456), as filed on April 13, 2000, and thereafter amended on November 19, 2010 and February 20, 2014, shall be further amended as follows:

Clause (b) of Article IV of the Articles of Incorporation shall be deleted in its entirety and the following shall be added in its place:

"ARTICLE IV

PURPOSES

The Corporation is organized and shall be operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986. In furtherance of such purposes, the Corporation shall be authorized:

(b) To enhance and improve the quality of life in and around Polk County, Florida, and in other locations around the world as requested by its

donors and approved by staff, or as otherwise directed by the Board."

The foregoing amendments were approved by the Board of Directors of the Corporation at a special meeting duly called and held on September 26, 2017, pursuant to written notice delivered not less than 14 days prior to the date of such special meeting, at which a quorum of the Directors and the Members was present and voting throughout, for the approval of such amendments, all pursuant to Section 617.1002, Florida Statutes. The number of votes cast for the amendment was sufficient for approval by the Members in accordance with the provisions of the bylaws of the Corporation.
